Since GST has a federal structure of taxation, it requires adoption of the standard frame work of classification across Centre and States. Accordingly, Harmonized System of Nomenclature (HSN), which is utilized by the Central Board of Excise and Customs is to be utilized for classification of Goods.

The classification of goods under GST, which shall be HSN based has certain patterns and methods to learn and use for classifying different commodities to be supplied under CGST / IGST / UTGST / SGST Acts, 2017.

Objective : Since the GST is based on self assessment it is imperative for trade and industry to classify the item correctly for payment of tax purpose. The objective of this one day program is to acquaint the participants with nuances involved in HSN classification for goods and services with a view to avoid legal issues subsequently.
