Individual Members

Any individual holding in the opinion of the Committee a responsible executive or administrative position in an industrial or commercial firm, government enterprise, consulting firm or any other like establishment, which involves the study and application of management principles and the effective utilization of human and material resources, also any individual teaching management subjects in an educational institution, shall be eligible for Individual Membership.

Individual Members will be of the following classes:

- **A. INDIVIDUAL ANNUAL MEMBER:** Any individual, who in the opinion of the Committee, is interested in the development of the management movement and who pays his or her membership subscription, as decided by the Committee on an annual basis, may be admitted by the Committee as an Individual Annual Member.
- **B. LIFE MEMBER:** Any person, holding in the opinion of the Committee, a responsible executive or administrative post in an industrial, commercial or professional organization or in a government or semi-government body or undertaking may be admitted as Life Members.
- **C. PATRON MEMBER:** Any individual eligible for Life Membership who pays his patron membership subscription, as decided by the Committee, may be admitted as Patron Member.

Documents required to be attached

- 1) Business card or any identification
- 2) Proof regarding last academic qualification

Completed application form with necessary documents should be submitted to AMA Office. This will then be placed before the Scrutiny Committee for consideration and approval by the Governing Council. The decision regarding the membership application will be communicated to the applicant. (Normally 4-5 weeks time will be required for approval).
